FILE SPECIFICATIONS:

All Supported Files:

Scans should be saved in CMYK, 300 dpi and in .EPS, .TIFF or .PDF format without compression.

Acceptable files:

InDesign CS3, Photoshop, .TIFF, .EPS, .JPG, .PDF (should provide proof for comparison)

Files with ink coverage (bleed) to the edges should have 1/8 inch bleed. Leave type and image safety margin of 1/4 inch from edge of finish size.
